A bylaw to amend the Septic Tank Effluent Disposal Rates and Charges.


WHEREAS the Regional Board of the Regional District of Central Okanagan adopted the Regional District of Central Okanagan Septic Tank Effluent and Regulation Bylaw No. 358, 1988.

AND WHEREAS the Regional Board deems it advisable to amend the said bylaw;


NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled enacts as follows:

1. The septic tank effluent disposal rates and charges, established by the "Regional District of Central Okanagan Septic Tank Effluent and Regulation Bylaw No. 358, 1988", as amended, are hereby further amended by deleting Schedule 'A', and replacing it with Schedule "A" attached hereto and forming part of this bylaw.
2. This bylaw may be cited for all purposes as the "Regional District of Central Okanagan Septic Tank Effluent and Regulation Amending Bylaw No. 1250, 2008".



Rates and Charges

- 1) Permit Fee..... \$100.00
- 2) Permit Renewal Fee \$10.00
- 3) Ammonia-N Surcharge (in excess of 0.5kg in every m³ of waste) \$10.00 per kg
- 4) Disposal Tipping Fee:
