BYLAW NO. 1283

Being a bylaw to amend the boundary of the June Springs Fire Protection Service Area.

---

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No.1021, 2003 cited as the "Regional District of Central Okanagan June Springs Fire Protection Service Area Establishment Bylaw No. 1021, 2003" a service to provide for fire protection.

AND WHEREAS the Regional Board wishes to exclude the Crown lands which were included in Bylaw No. 1021, and which are identified in Schedule A in green, so as not to be responsible for fire protection of these lands;

AND WHEREAS the Director of Central Okanagan East Electoral Area has consented in writing to the adoption of this Bylaw;

NOW THEREFORE THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The boundary of the June Springs Fire Protection Service Area, established by the "Regional District of Central Okanagan June Springs Fire Protection Service Area Establishment Bylaw No. 1021, 2003", is hereby amended by deleting Schedule "A", and replacing it with Schedule "A" attached hereto and forming part of this bylaw.
2. Delete Ellison/Joe Rich Electoral Area in its entirety and replace with Central Okanagan East Electoral Area.
3. This bylaw may be cited as the "Regional District of Central Okanagan June Springs Fire Protection Service Area Amending Bylaw No. 1283, 2011".

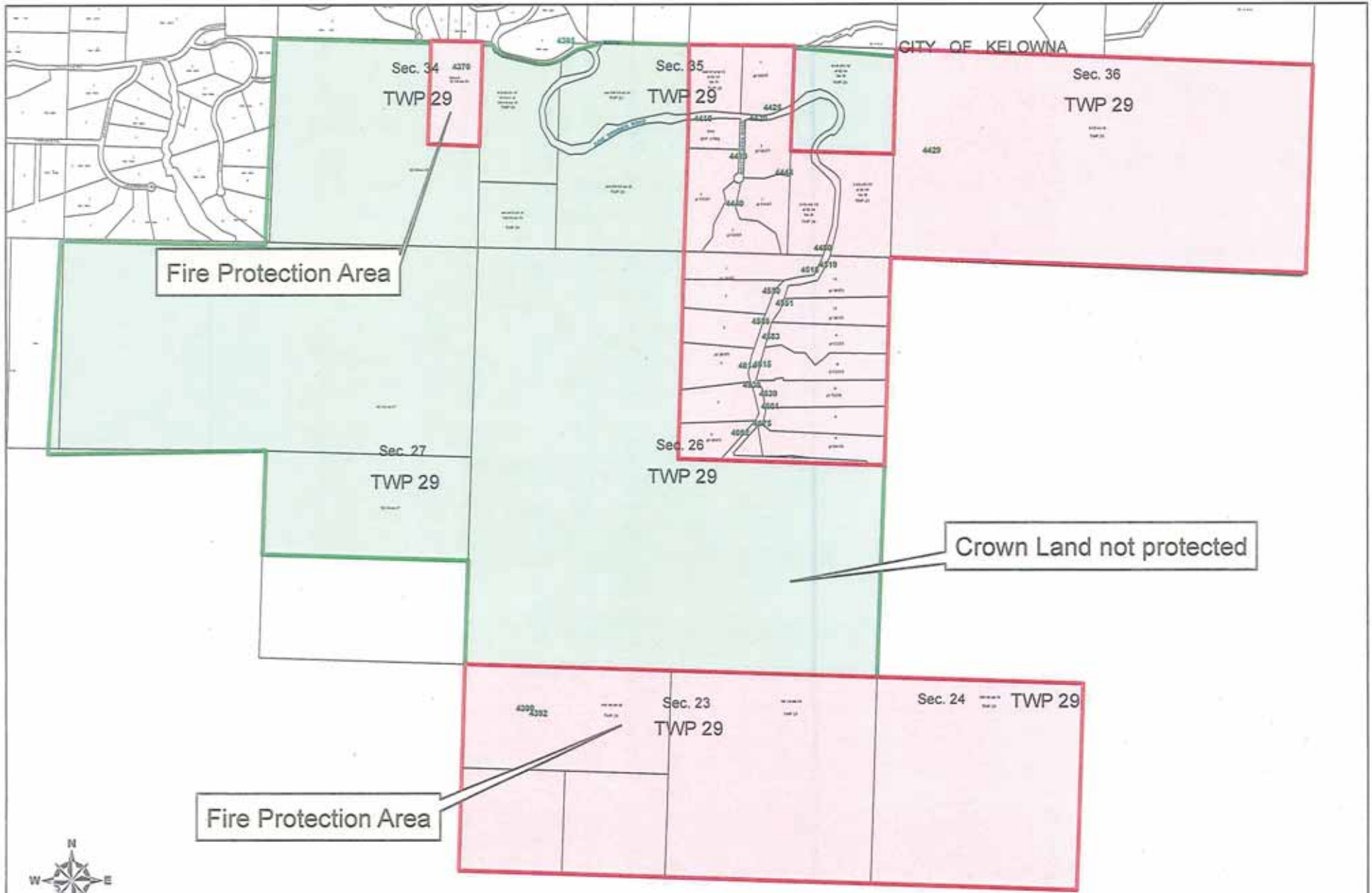

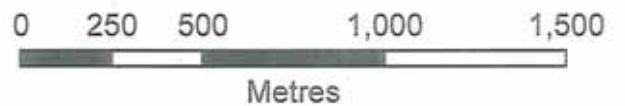


