Agricultural Land Reserve Appeal

5.2 Application to exclude land from the ALR for Tolko Industries Ltd. (owner), Kent Macpherson (agent) located adjacent to Westside Road (A-15-01) Central Okanagan West Electoral Area (*All Directors – Unweighted Vote*)

Staff report dated May 19, 2015 outlined the application to obtain Agricultural Land Commission approval to allow the 1.07 ha Agricultural Land Reserve (ALR) portion of the 7.7 ha property to be excluded from the ALR. The property is owned by Tolko Industries It has not been used for agricultural purposes in the past. It has previously been used by the Ministry of Transportation and Infrastructure for a graving dock staging area to construct components of the William R. Bridge. The current landowner has no immediate plans for the property and will consider potential future options that reflect the best use of the land.

5.3 Zoning Amendment Bylaw No. 871-226 for Aljac Holdings Company Ltd. c/o /Monashee Surveying and Geomatics to amend the Permitted Uses Table for the RU2 Rural 2 zone, Section 6.2.1 by adding a new subsection 6.2.1.18 - On Lot 1, Plan KAP12705, District Lot 2198, ODYD the following additional use is permitted: 2 residential dwelling units located adjacent to Kilkenny Place, Westside Road and Okanagan Lake. Central Okanagan West Electoral Area (Z14/06) (All Directors - Unweighted Vote)

Staff report dated May 19, 2015 outlined the zoning amendment. First reading was deferred in January 2015. Two seasonal dwellings exist on the subject property, however only one single detached house is permitted. The proponent has substantiated the historic use of the site, has agreed to register a covenant on title restricting each dwelling unit's footprint, and submitted a preliminary sewage dispersal assessment based on seasonal use. One dwelling is legal conforming and the other non-conforming.

9. NEW BUSINESS

9.1 Fire Services Review – Central Okanagan East & West Electoral Area – Approval of Scope of Work (All Director – Unweighted Vote)

The scope of the work for the 2015 Central Okanagan East & West Electoral Area Fire Services Review was outlined. The Board has approved \$75,000 in the 2015 budget for an independent review. The scope of the review assignments include: finance, bylaw and policy review; training, recruitment, retention and record keeping; long term strategy; and organizational structure.

The four paid-on-call fire departments are: Ellison, Joe Rich, North Westside and Wilson's Landing. It is anticipated a consultant will be named by July with all deliverables achieved by mid-September. Staff noted there have been a number of reviews done in other local governments, therefore it is likely there will be a number of skilled consultants who are qualified to do this work.

It was noted that the 'playbook' brings new requirements for consideration. Looking at the 'playbook' and how it impacts all the fire departments will be part of the review. Service levels outlined in the 'playbook version' will need to be discussed with the volunteer departments and consideration whether the community wants a higher level of service and, if so, what the costs would be. Further discussion will need to be done to understand if that service can be delivered. The review is staged so it will depend on the initial findings in order to determine whether further work is required, and therefore further costs.
