**Purpose:** To comply with legislative requirements under the *Financial Information Act* and its regulations the Statement of Financial Information Disclosures are presented.

## Executive Summary:

The 2017 Statement of Financial Information (SOFI) schedules are submitted for approval as required under the *Financial Information Act* and its regulations. The Audited 2017 Financial Statements were previously approved by the Board on May 10, 2018 and are posted on the RDCO's website and are also available at the RDCO Office at 1450 KLO Road.

In 2017, the RDCO had over \$5m of extraordinary expenditures for Flood and Fire responses which were reimbursed by Emergency Management BC.

### Implications of Recommendation:

Strategic Plan & Financial: The 2017 – 2021 Financial Plan, Department Initiatives and Program Plans were approved in March 2017, with amendments throughout the year. Expenditures were made in accordance with the Financial Plan.

### Background:

These Schedules form part of the Statement of Financial Information Package that is submitted to the Ministry of Community, Sport and Cultural Development under the *Financial Information Act*.

#### Notes:

\* **Board remuneration:** Increase is mostly due to a \$5k payment timing swing for one director's remuneration. (2016 was \$12,899 vs. \$17,922 in 2017 – regular annual amount for 2017 should be \$15,579).

\*\* **Employee remuneration:** Includes \$160,433 relating to emergency responses for floods and fires, which was reimbursed by Emergency Management BC. The number of employees exceeding \$75,000 increased by 2, or 6.7%. Even with extensive overtime for emergency responses, overall remuneration for all employees increased by \$186,126, or 2.2%. If the emergency overtime is removed, the increase is less than 1% at 0.3% or \$25,693 (\$186,126-\$160,433).

Amounts over \$25,000 paid to suppliers for goods and services totaled \$17,987,687 in 2017, vs. \$11,480,953 in 2016. In 2017, due to floods and fires, there was an additional extraordinary \$5 million of expenditures made, that was reimbursed by Emergency Management BC. There was also significant spending on capital projects for water systems and the wastewater treatment plant.

The Ministry deadline requires that this information be made public by June 30, 2018.
