2. DELEGATION

2.1 Sandra Kochan & Robert Hobson – Okanagan Cultural Corridor Project Update

Sandra Kochan gave an update on the 3-year old Cultural Corridor project supported by initial funding from the provincial Ministry of Community Development, Cooperatives and Volunteers (2000-2001) and Tourism BC (2001-2002) and currently funded through Western Economic Diversification Canada and investment from individual cultural attractions (2002-2003). Additional contributions have been provided by Community Futures-Central Okanagan and the Regional District of Okanagan Similkameen. Financial administration is provided as an in-kind contribution by the Regional District of Central Okanagan.

The geographic area encompassed by the project is within the boundaries of the three regional districts of Okanagan-Similkameen, Central Okanagan and North Okanagan.

The project markets the region as a cultural destination, has compiled a catalogue of more than 200 cultural attractions, printed and distributed a full color guide for over 120 attractions, a 3-year research program partnered with Tourism BC and Community Futures is underway, and has developed a website. The project is managed by a steering committee and is currently working on funding proposals to assist with implementation of marketing plan.

Sandra Kochan requested a letter of support from the Regional Board for a grant application to Softwoods hdustry Community Economic Adjustment Initiative (SICEA). The project budget of \$200,000 is for product development and marketing budget

Discussion:

The Board congratulated the steering committee on the project and questioned who has been involved in the project, the criteria used to advertise, the cost of advertising and the publication schedule of the print guide. Directors were requested to put in writing any suggestions for additions to the next guide that is scheduled to be published in 2005.

3. CORRESPONDENCE

3.1 Letter: J.A. Martin re: concerns regarding fire hazards in public reserve areas

The Board discussed the concerns noted in J.A. Martin's letter. Staff confirmed that numerous calls and letters have been received regarding fire hazards since the Okanagan Park Fire began. The Parks Department is working on developing a new program that will involve the public in cleaning up the public interface. This approach will greatly reduce fuel load in regional parks. Staff will continue to work with Forestry with urban interface issues.

Discussion:

 Thompson Okanagan Interface Committee will be hosting a symposium in March 2004 for municipal politicians and staff to discuss rural/urban interface initiatives.

- Parks does not have the financial or staff resources to handle a cleanup the magnitude of all the regional parks. Parks is developing a program response and not just responding to individual concerns on specific sites.
- Concern was expressed regarding the liability of the public going into parks to do fire hazard cleanup.
- Need to develop a regional interface strategy that must involve various departments and agencies. There is a need to balance the issues involved. The Regional District to take lead in this strategy--not just a cleanup of public and private lands.
- Need to do a post-mortem when the fire is out.
- Communicate through the press to make the public aware of urban interface issues. The Ministry of Forests publishes a handbook which is available on their website.

It's been a mammoth effort and the Board thanks you and your family for your time and effort during what has been a trying time for many in our region

Discussion:

- Need to be clear on the role of the Regional Board during an emergency protocol to be reviewed.
- If this had been a local state of emergency the Board would have been much more involved. When a provincial state of emergency occurs, such as the Okanagan Park Fire, the Province is in charge.
- Need to recognize that there is a need to keep the Board informed the emergency plan will be changed to make a good plan a better plan – post mortem will be done.
- Regional District supported Idabel Lake evacuation although this area is in the boundary of the Kootenay Boundary Regional District.
- The City of Kelowna is in charge of managing the fire recovery efforts

Directors Harriman and Dinwoodie brought forward a proposal for the building of an exit ramp from the Coquihalla Connector into Peachland. As Hwy.97 is the only exit out of Peachland, it is felt that an exit is a priority as there would be no access out of or into Peachland in the case of an emergency. The District of Peachland has been able to secure a commitment for funding from the Province for the ramp.

The Board discussed the proposal and expressed concern regarding the process followed, the fact that staff had not had an opportunity to review and report on the proposal and that there is a policy on late items to the Board. It was noted that confirmation of the Westside Electoral Area's funding contribution will need to be finalized and that this will be brought back to the Board with a final report. As the Province and the District of Peachland has committed the funds and as the window for construction to complete the project by year-end is short, it was felt that the issue requires immediate attention.

- a) the Province of B.C. contributes a minimum of \$525,000.00;
- b) a minimum of \$135,000.00 be contributed by the District of Peachland;
- c) And there be \$50,000.00 in gravel and in-kind be provided by an arrangement made by the District of Peachland.

CARRIED

ACTION: Staff to confirm what revenue sources are available for Electoral Area Westside's portion to be allocated to the on/off ramp from the Coquihalla Connector to Peachland and will report back to the Board.

9.6 Municipal Finance Authority

Chair Hobson confirmed that the Municipal Finance Authority has given the Regional District \$5000., as they have to the Thompson Nicola Regional District, to assist the Regional District in developing a strategy for economic recovery for the region based on the results of the fire.

9.7 Kettle Valley Railway Trestles

Chair Hobson reported that a conference call was held early today with Federal, Provincial and local officials to discuss what can be done with the Kettle Valley trestles. They agreed that a technical committee will be formed to look at three phases to restore the trestles: assessment of damage, planning for reconstruction and rehabilitation and fundraising. There was not commitment for funding other than the Federal government is prepared to pay for the assessment.

Ideas such as charging a fee to raise the bridge or limiting hours during an emergency were discussed.

Concern was expressed that the bridge is the only access out of Kelowna to the West and is in need of replacement and may not be able to handle an evacuation should it be required. It was agreed that pressure needs to be put on the Province to move forward with replacement of the bridge.
