partnerships involved with CATCH--15 community network partners and funding status. CATCH is not a funding agency, but will advocate for a funding infrastructure that builds community assets and a community plan for early childhood development. CATCH does not work directly with children – they facilitate with partner agencies that work with children. CATCH received a three-year grant of \$250,000 from the Ministry of Children and Family Development. The funds support the team's initiatives. Lynn Malinsky reviewed the plans for funding when the three-year grant is completed: Success by Six is matched dollars by the Ministry of Children and Family Development, Credit Unions, United Way. At this time there are no funding requirements from the Regional Board.
